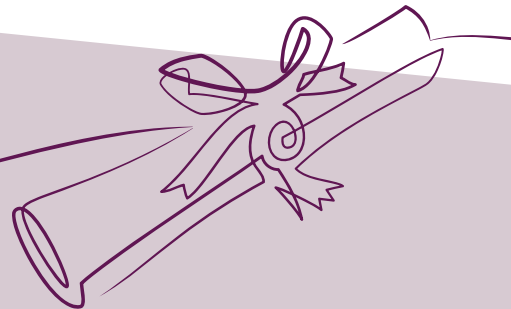
Lifelong Learning² is an easy-to-use online library of learning. Giving members access to hundreds of courses to learn a new skill, improve work skills, or explore a new interest.

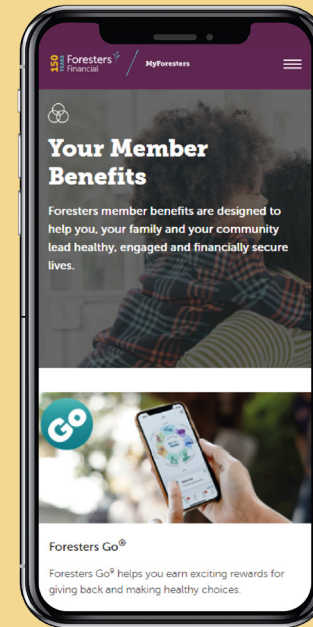
